 1. Detailment of the Civil Judge-cum-Judicial Magistrates concerned is hereby recalled. They are directed to report back to their original place of posting.
- 2. The District & Sessions Judges concerned are directed to arrange the attachment of newly appointed
- Civil Judges-cum-Judicial Magistrates with seasoned Civil Judge-cum-Judicial Magistrates for a period of 15-working days and shall submit their report to the High Court.
- 3. The District & Sessions Judges concerned shall distribute the cases of vacant courts and case which do not fall in the jurisdiction of Newly appointed Civil Judge cum Judicial Magistrate amongst the Judicial Officers equally.
- 4. The District & Sessions Judges shall take necessary steps for equalization of cases amongst the courts in their respective districts.
- 5. The newly appointed Civil Judge-Cum-Judicial Magistrates are directed to take the charge with immediate effect before the commencement of Eid vacations.
