
**OFFICE ORDER:**

- The Judicial Officers on duty shall entertain only urgent criminal and civil matters as already specified in the ibid Notification.
- All the trial cases be adjourned after Eid-ul-Fitar and concerned counsel be informed accordingly besides the cause lists of the adjourned cases be affixed on the notice board of the concerned courts as well as the same be uploaded on the official website of the District. Whereas, the Miscellaneous Petitions etc. upon completion of duty period of one Judicial Officer be sent to the next Judge on Duty.
- The Judicial Officers before proceeding on leave shall make order in writing regarding presence of at least one Clerical Staff for duty during the leave period on rotation.
- Replacement of duty in case of any emergency of the Judicial Officer be communicated to the undersigned whereas with regard to the staff be communicated to the concerned Judicial Officer well in advance.

- All the UTPs and others waiting for trial be exempted from personal appearance and the Judicial Magistrate on duty shall visit the jail on daily basis for extension of Judicial Remand of the UTPs, disposal of petty nature cases as well as others waiting for trial inside jail.




