

ORDER  
13.03.2020

The above-named petitioner on 26.02.2020 submitted an application to the DPO Orakzai requesting thereby the registration of FIR against the respondents namely Sheheen, Muhammad Hanif, Minhaj, Sheerin, Muzahir, Manno and Abdullah to the effect that they have cut 1500 to 2000 walnut trees roots by extracting *Dandasa* and selling the same thereafter. The DPO Orakzai marked the said application to the SDPO Upper Orakzai for necessary action as per law but having received no response from the local police, the application in hand is submitted before the present Court.

(2). Upon the submission of application, comments were invited from the SHO Police Station Upper Orakzai, which

comments were submitted today wherein it is mentioned that the application of the petitioner is based on facts yet no FIR despite the offence committed being cognizable was registered.

- (3). When the application of the petitioner was based on facts, the SHO PS Upper Orakzai was supposed to register the FIR. However, at the moment, application in hand stand accepted and the SHO PS Upper Orakzai is directed to register an FIR under the relevant sections of law against the above-named respondents. The copy of FIR be submitted before the undersigned within three days from today.
- (4). Copy of the order be sent to the DPO Orakzai for issuance directions to all the SHOs of District Orakzai for registration of FIRs in every cognizable offence without waiting for the order of the Court in this respect.
- (5). File be consigned to Sessions Record Room after its necessary completion and compilation.


