The petitioner, Wazir Khan through the petition in hand requested for the registration of FIR against eight persons alongwith thirty unknown persons named in para 2 and 3 of the petition to the effect that on 23.04.2020, the said respondents came to their jungle and have cut more than 200 palm trees belonging to the petitioner. That upon retraining, the respondents threatened the petitioner besides the respondent Nahir Haji and Sawab Khan made firing at him by means of pistol. It was alleged that an application was submitted to the DPO Orakzai on 05.05.2020 but of no use. Hence the application in hand.

- (2). Comments were invited from the SHO concerned who submitted the same alongwith inquiry report which support the version of the petitioner to the extent of cutting of palm trees besides it was mentioned that the property in question is disputed between the parties for which earlier an FIR was also lodged on the same motive against the petitioner. As such cognizable offence seems to have been committed.
- (3). Therefore, in the light of above, petition in hand is accepted and SHO PS Lower Orakzai is directed to register an FIR under the relevant sections of law against the respondents named in para 2 and 3 of the petition. Notice to this effect be issued to the SHO concerned alongwith copy of the order for compliance.
- (4). File be consigned to Sessions Record Room after its necessary completion and compilation.
