**Order No. 07**

Petitioner No. 01 through Raziq Ali as attorney for rest of the petitioners along with counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Anaz Ali, who died on 31/10/2017. Arguments heard and record perused.

2. Through publication in daily newspaper "Ausaf" dated; 26th May, 2019 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.

3. Petitioner No. 01 Armoos Begum, 02. Younis Khan, 03. Asma Begam, 04. Alma Begum and 05. Neelam Batool filed the instant application. Attorney of the petitioner recorded his statement as PW-1, while Bakhtia Ali as PW-2 and Awal Khan as PW-3 testified respectively. PW-1 submitted his power of attorney as Ex. PW-1/1 and copy of his CNIC Ex.PW-1/7, copy of death certificate of deceased as Ex. PW-1/2, copy of deceased CNIC is Ex. PW-1/6, copy of CNIC of petitioners No. 1 is Ex.PW-1/6 (A), copy of Form-B as Ex. PW- 1/5, Copy of No objection certificate of Dead Body PW-1/3, copy of family tree Ex. PW-1/4 Copies of CNICs of PW-2 and PW-3 is Ex. PW-2/1 and Ex. PW-3/1. All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.

4. As, there is nothing in rebuttal, so therefore contention of the petitioners is believed to be correct. Therefore, the petitioners will inherit the legacy of deceased as per following shares;
