
The instant pre arrest bail application along with record received from the court of Honourable Session Judge Orakzai. It be registered. Accused/petitioner on ad-interim pre-arrest bail along with Mr Noor Kareem Orakzai advocate learned counsel for the accused/petitioner and Mr. Sana Ullah advocate, learned counsel for complainant along with complainant present.

The accused/petitioner Zaliman Shah s/o Gul Maan Shah r/o Khangar Boor District Orakzai is seeking the confirmation of his ad-interim pre-arrest bail in case FIR No.19 dated 11/05/2020 u/s 506/447 PPC PS Upper Orakzai (Ghiljo).

Brief facts of the case are that the instant FIR was registered against accused/petitioner on the application of complainant Khadim Gul wherein the complainant submitted that on 19/03/2020 when complainant visited his landed property their the accused restrained him from ploughing his land and extended threats; that on 05/04/2020 the accused again threatened him and asked the co villagers neither to plough his land nor to take the same on lease and extended threats to the tenants. The application u/s 22-A Cr PC of the complainant was accepted vide order dated 30/04/2020 of the Honourable Session Judge Orakzai and the present FIR was registered against accused/petitioner.

Arguments for the learned counsel for the accused/petitioner and counsel for the complainant heard today and record perused.

During the course of arguments both learned counsels for the parties and the parties also agreed that if the accused submit affidavit before the

court that the accused shall not restrain the complainant to go to his fields and the accused shall not interfere in any manner in the property of the complainant and the complainant shall be at liberty to cultivate and take benefits from his property, the complainant shall got no objection on the confirmation BBA of the accused/petitioner. The accused/petitioner in view of the above submitted an affidavit and the complainant and his counsel are agreed and satisfied to the affidavit submitted by the accused/petitioner. The affidavit is duly thumb impressed by accused/petitioner which is placed on file

In view the affidavit submitted by accused/petitioner, the bail petition in hand is accepted and the ad-interim pre-arrest bail granted to the accused/petitioner vide order dated 12/05/2020 is hereby confirmed on the strength existing bail bonds.
