Judgement



SUIT FOR DECLARATION & PERMANENT INJUNCTION

SUMMARY JUDGEMENT:
ORDER XV-A CPC

1. Plaintiff, **Abdul Wahid s/o Sabit Khan**, has brought the instant suit for declaration-cum-permanent injunction against the defendants, referred hereinabove, seeking therein that his correct date of birth is **13/04/1997** and his correct father name is Sabit Khan (ثابت خان), while it has been wrongly mentioned as **1989** and father name as **سابت خان** by the defendants, which is unnatural as there is not a single year difference between the age of the plaintiff and his elder sister, which is against the **nature**. Hence, the instant suit.

2. Defendants were summoned, who appeared through attorney namely **Syed Farhat Abbas** and submitted written statement, which is placed on file.


During the scheduling conference within the meaning of order IX-A of CPC, it was agreed by the defendants that there is no difference of age between the plaintiff and his sister, while his sister is elder than the plaintiff. Secondly, the father name of the plaintiff is ثابت خان so, defendants have got no objection to grant decree in favour of the plaintiff. Even otherwise, the same is even evident from the SSC (school certificate) of the plaintiff, copy of which is present on file.


Relief:

Consequently, upon what has been discussed above and the jurisdiction vested in this court under order XV-A of CPC, suit of the plaintiff succeeds and is hereby decreed as prayed for. Defendants are directed to correct his date of birth as 13/04/1997, and his father name as ثابت خان forthwith.
