Record perused.</p> <p>Petitioner Shahnawaz Khan seeks Superdari of 11 pair of Land Patri (22 in number), 01 drill machine, 01 generator charger and 02 peaks taken into possession by local police of PS: Kurez Boya, L/Orakzai, vide Case FIR No. 43, Dated: 27.10.2023, U/S 379/34 PPC.</p> <p>Hearing the arguments of learned counsel and perusing the record it appears that petitioner is the complainant in the case. In the FIR, he had reported the items under consideration as stolen. The same were recovered from the accused on 27/10/23. No claimant, other than the petitioner, has so far appeared. Today, in the trial running parallel to the petition, the items have duly been exhibited in the statement of the IO, were examined by the court, and pictures were taken, in support of the proceedings. Photographs of which are placed on file as Ex.P-1 to Ex.P-4. The aforesaid case property is no more required to the local police for investigation or any other purpose. There is no rival claimant of the said case property at present. Moreover, there is strong apprehension of the damage to the case property if kept in the PS for indefinite</p>
