To this effect their joint statement was recorded and placed on file, wherein they stated that, as accused belongs to merged district and do not know about the trial proceedings of the case, that's why accused has been gone to UAE and did not appear for trial proceedings.</p> <p>Now as per contention of sureties, parties had patched the matter through a compromise deed and they further have got no objection if this court release the sureties in the instant case.</p>
