

Accused/petitioner in person present.</p> <p>Vide this order the Court intend to dispose of the instant Superdari petition filed by petitioner Sami Ullah son of Shaheen who is seeking return of one Laptop Dell Core i2 computer alongwith charger, previously taken into possession by local police of Police Station Mishti Mela, in Case FIR no. 54 dated 26.09.2024 under section 419/420/471 of Pakistan Penal Code.</p> <p>Arguments already heard and record perused.</p> <p>Brief facts of the case are that case property in shape of Laptop in question was taken into possession by the local police in the above cited case. Per FIR, the local police of police station Mishti Mela recovered one computerized service card, of CTD Police Department. The accused also introduced himself as employee of the CTD Police regarding which inquiry through the CTD police Kalaya was made, who confirmed that there is no constable in the name of Nusrat Ameen in CTD Police. During investigation accused Nusrat Ameen disclosed that the same was prepared and printed for him by one Amjad Nawaz who is working in the Canteen of the District Headquarter, Orakzai at Baber Mela. Accused Amjad Nawaz in his statement under section 161 Cr. PC disclosed that he is working as employee of the Sami Ullah, the present petitioner.</p> <p>Now the petitioner through instant application alleged that he is the real owner of Laptop in question and seeks return of the same on superdari.</p>

	<p>Perusal of the recovery memo would reveal that Laptop in question was recovered from the possession of present petitioner.</p> <p>OII submitted report regarding the case property i.e. Laptop and alleged that all the data has been deleted from the laptop in question and further there is no facility available in FSL for recovery of data. The report also shows that investigation has already been completed in the FIR case. Furthermore, there is no rival claimant present before the court. Furthermore, no such valid reason or sufficient cause has been disclosed by prosecution in order to dismiss instant application.</p> <p>Hence, keeping in view the aforesaid discussion instant Superdari petition is hereby allowed and petitioner Sami Ullah is hereby directed to submit bonds worth Rs-100,000/- with two local and reliable sureties, each in like amount to the satisfaction of SHO PS Mishti Mela Orakzai. After submission of bonds, Laptop core i2 alongwith charger be handed over to the petitioner Sami Ullah. Police record be returned forthwith.
