In such like cases grant of bail is a rule and refusal an exception. Additionally, nothing incriminating has been recovered from possession of the present accused/petitioners or on their pointation. Medico legal report does not support the version of prosecution. The case of accused/petitioners is one of further inquiry.

Consequently, application in hand is allowed. Petitioner be released on bail subject to furnishing bail bonds in the sum of Rs. 100,000/- (one lac) with two sureties each in the like amount to the satisfaction of this court. Copy of this order be placed on police as well as judicial record. Record be returned back to the quarter concerned.
