

No one for complainant present.</p> <p>The accused/petitioners namely (1) Shakeel son of Yar Bat Shah and (2) Muhammad Ullah son of Peer Bat Khan, both residents of Saifal Dara, District Orakzai have applied for their post arrest bail in connection with case FIR No. 27, dated: 24.10.2024 under sections 186/189/506/34 Pakistan Penal Code, registered in police station Ghiljo District Orakzai.</p> <p>Arguments on behalf of counsel for accused/petitioner already heard while APP for State advanced his arguments.</p> <p>Brief facts of the case as per the prosecution that the accused/petitioners duly armed and started ineffective firing upon complainant party for criminal intimidation.</p> <p>Upon perusal of record reveals that accused/petitioners are directly and by name charged in the instant FIR for the commission of offences, however, the offences levelled against the accused/petitioner does not fall within the ambit of prohibitory clause of section 497 Cr.PC.
