

Brief facts of the case in hand are that plaintiffs have filed the instant suit against the defendants for declaration cum permanent injunction to the effect that plaintiffs are legal heirs of Adeen Nawasi and belong to Najeeb Khan tabar. That plaintiffs are owners in possession of 1/5<sup>th</sup> shares of the suit property situated at Khando, Kada Kalaya effected long ago. Furthermore, plaintiffs are owners in possession of 1/5<sup>th</sup> share of the suit property situated at Nakhtaro Ghar, which is the joint ownership of the parties to the suit. Defendants were asked time and again to not interfere with the suit or cutting forest erected over the suit property but they refused, hence, the present suit.

Under the due process of law and procedure defendants were summoned. Defendants in person appeared before the court and marked their attendance.

File be consigned to record room after its necessary completion and compilation.


