SUMMARY JUDGEMENT 17.12.2024

Son of plaintiff along with counsel present. He filed special power of attorney on behalf of plaintiff. Representative of defendants also present. He submitted written statement along with relevant NADRA record of plaintiff. Counsel for plaintiff requested for summary disposal of the suit. Representative of defendants stated that per record, there is unnatural age gap of 11 years between plaintiff and her son namely Ahmad Ullah, therefore, if suit of plaintiff is

disposed of through summary judgement, he has got no objection.

Arguments heard and record gone through.

Brief facts in the backdrop are that plaintiff namely Tasleem Bibi has filed the instant suit for declaration cum-permanent injunction against the defendants Chairman NADRA, Islamabad and two others to the effect that, true and correct date of birth of plaintiff is 01.01.1976, however, defendants have incorrectly entered the same as 01.01.1984 which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. It is further averred that due to this wrong entry, there is unnatural age difference of about 11 years between plaintiff and her son namely Ahmad Ullah whose date of birth is 01.01.1995. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter and written statement along with relevant NADRA record of plaintiff was filed.

Representative of defendants stated that there shall be at least 16/17 years' age difference between mother and her son. Per record,

date of birth of plaintiff is recorded as 01.01.1976 while date of birth of plaintiff's son namely Ahmad Ullah is recorded as 01.01.1995 resulting into unnatural age difference of about 11 years between plaintiff and her son named above. Plaintiff is not a government servant. The modification sought by plaintiff will not affect rights of others. Representative of defendants stated that date of birth of plaintiff may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify/modify date of birth of plaintiff as 01.01.1976. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
