Sr.PP, Abul Qasim for the State present.

Accused/petitioner, Sami Ullah on ad-interim pre arrest bail along counsel Mr. Abid Ali Advocate present.

- (2). Accused/petitioner, Sami Ullah s/o Shaheen is seeking his pre-arrest bail in case FIR no. 54, dated 26.09.2024 u/s 419/420/471 PPC of police station Mishti Mela
- Mishti Mela arrested after recovery of one computerized service card, of CTD Police Department, in his name. The accused also introduced himself as employee of the CTD police regarding which inquiry of the CTD police Kalaya was made, who confirmed that there is no constable in the Nusrat Amin s/o Star Zai in CTD police. The card was taken into possession and he was charged u/s 419/420/471 PPC in the abovementioned FIR.
- (4). During investigation accused Nusrat Amin disclosed that the said card was prepared and printed for him by

one, Amjid Nawaz who is working in the Canteen of the District Headquarter, Orakzai at Baber Mela. Said Amjid Nawaz on 10.10.2024 in his statement u/s 161 Cr. PC disclosed that he is working as employee of one Sami Ullah (present petitioner) in the canteen situated at Baber Mela and that he is prepared the said card at the direction of Sami Ullah present accused/petitioner.

- Arguments heard and available record perused (5) which shows that the present accused/petitioner is not directly charged in the FIR, no recovery has been effected from his personal possession or from his canteen. Astonishingly the present accused/petitioner is charged after 25 days of the loading the FIR. Furthermore, the main accused namely, Nusrat Amin and co-accused Amjid Nawaz have already been released on bail and it is reported in various judgments of superior courts that if the case of accused otherwise fit for bail then keeping him in jail will serve no useful purpose. I, therefore, the instant application is accepted the ad-interim bail earlier granted to the accused/petitioner is confirmed on the strength of existing bonds. Record be returned to the quarter concerned.
