**ORDER**

The petitioner seeks registration of FIR against respondents no. 2 to 9 based on the allegations that on 27.08.2024 respondents no. 2 to 9 have demolished the boundaries of the petitioner's house, hurled stones at the house and his cattle and cut the branches of the walnut trees. The petitioner further claimed that he has approached respondent no. 1/SHO, but to no avail; hence, the present petition.


(2). The SHO concerned was directed to furnish his comments which he accordingly did. Placed on file.

(3). Arguments heard and record gone through.

(4). The law on the point is that a matter constituting a cognizable offence is whenever reported to police, the SHO concerned is bound to enter the substance of the matter on the roll of prescribed register u/s 154 Cr.P.C and proceed to investigate the matter u/s 156 Cr.P.C. In the instant case, as per comments furnished by the SHO concerned, an FIR has already been lodged involving the same matter. Moreover, the current matter appears to be of a civil nature, leading to the conclusion that the malicious intent to drag each other in false cases, cannot be ruled out.

(5). In these circumstances, the petition in hand is dismissed as it fails to meet the legal prerequisites for intervention under Section 22-A CrPC. Needless to mention that the petitioner may approach the concerned forum for redressal of his grievance. Order announced. File be consigned to record room after its necessary completion and compilation.


