Contin- Order No. 02 Arguments of the Sr. PP for the State heard on his application u/s 4C (II), 5 (b) of the Prosecution Act, 2005, read with section 494 Cr. PC. Record perused.

The perusal of record shows that there is nothing on the case file to connect the accused facing trial with the commission of offence. Neither he is arrested at the spot, nor any recovery has been effected from his possession. He is charged by the main accused namely Hashmat Ullah in his statement recorded u/s 161 Cr. PC, which is not admissible evidence against him under in the law. The accused has not confessed his guilt before the police or the area Magistrate and there is no probability of the conviction of the accused due to non-availability on sufficient evidence collected against him. The ultimate result of the case will be acquittal of the accused facing trial even if the evidence mentioned in the Challan is recorded. Resultantly the instant application being based on reasons is hereby accepted and the accused Alla Baz is hereby discharged under section 4C (II), 5 (b) of the Prosecution Act, 2005, read with section 494 Cr. PC.
