

Accused facing trial at the very out set stated at the bar that he wants to confess his guilt in the instant case and in this respect he also submitted an application for plead guilty, which is placed on file.</p> <p>Brief facts of the case are that as per version of the complainant in the FIR, on 02.12.2024 at about 16:30 hrs complainant SHO was on patrolling and laid barricade. That one person coming from Head Quarter Chowk in suspicious condition was stopped for the purpose of checking. Upon his body search the local police recovered and took into possession one plastic envelope containing 45-grams ice from the side pocket. Accused was arrested and issued his card of arrest.</p> <p>Complete challan against the accused was put in court and after 241-A Cr.P.C proceedings, the accused facing trail was formally charge sheeted. Accused Shah Nawaz pleaded his guilt and requested for lenient view. After pleading his guilt, show cause notice under section 243 Cr.P.C. was given to the accused as to why he should not be convicted. Resultantly, he prayed for lenient view while placing himself at the mercy of this court.</p> <p>It is also pertinent to mention here that there is nothing such available on the record which could suggest that accused was previously involved in such like cases. In default of non-payment of fine the accused shall undergo simple imprisonment for a period of twenty days. Benefit of 382-B Cr.P.C. is extended to the accused.
