Per record, there is no criminal history of accused/petitioner. Accused/petitioner has not confessed his guilt before the court. No FSL or arms expert report is placed on file.</p> <p>Investigation has already been completed and accused/petitioner is no more required to the local police for further investigation and no useful purpose would be served by keeping the accused/petitioner behind the bar.</p> <p>Resultantly, application in hand is allowed. Petitioner be released on bail subject to furnishing bail bonds in the sum of Rs. 70,000/- (Seventy thousand) with two sureties each in the like amount to the satisfaction of this court. Copy of this order be placed on police as well as judicial record.
