# SUIT FOR DECLARATION, PERMANENT AND MANDATORY INJUNCTION

# **SUMMARY JUDGEMENT:**

permanent and mandatory injunction against the defendant, referred hereinabove, seeking declaration therein that correct date of birth of the plaintiff is 01.01.1962 while defendant have incorrectly entered the date of birth of plaintiff as 01.01.1972, in his record, which is wrong and ineffective upon the right of the plaintiff and liable to correction. Furthermore, due to said wrong entries there exists an un-natural gap of twelve years between the ages of plaintiff and her son namely Barkat Ali, bearing CNIC No. 21603-

3809003-9. That the defendant was repeatedly asked to correct the date of birth of plaintiff but he refused, hence, the instant suit.

- Today representative for defendant appeared before the court and submitted authority letter and written statement, which are placed on file. Notice of summary trial of the instant case was issued to the defendant through its representative.
- During the scheduling conference within the meaning of order IX-A of CPC, it was revealed that the matter involved in the instant case is of very petty nature, which can be decided through summary judgement as relevant record, without recording lengthy evidence. As the primary aim and objective of Amended Management Rules in CPC is, "to enable the court to-

Deal with the cases justly and fairly; a.

Save expense and time both of courts litigants; and

d. Enforce compliance with provisions of this Code."

Learned counsel for plaintiff heard and record gone through.

Record reveals that plaintiff through instant suit is seeking correction of date of birth to the effect that correct date of birth of plaintiff is 01.01.1962 while defendant have incorrectly entered the date of birth of

plaintiff as 01.01.1972 in his record by the defendant, which is wrong, ineffective upon the right of the plaintiff and liable to correction. Plaintiff in support of her contention produced the copy of CNIC of her son namely Barkat Ali bearing CNIC No. 21603-3809003-9, wherein the date of birth is mentioned as 11.05.1984 which shows there exists un-natural gap of twelve years between the ages of plaintiff and her son, which is impossible and against the order of nature. The said document clearly negates the existing date of birth of plaintiff as incorporation of 01.01.1972. Further, there is no countered document available with the defendant to rebut the document produced by the plaintiff in support of her contention. So, the available record clearly establishes the claim of the plaintiff.

4. Consequently, upon what has been discussed above and the jurisdiction vested in this court under order or
