

Learned counsel for plaintiff requested for summary disposal of
the suit on the basis of available record. Representative of defendants
conceded the same. Arguments heard and record gone through.


Brief facts in the backdrop are that plaintiff has filed the instant
suit for declaration cum-permanent injunction to the effect that, as per
Detailed Marks Certificate (matric) and Matric Certificate his true and
correct date of birth is **01.01.1991**, however, defendants have incorrectly
entered the same as **1986** which is wrong, illegal and ineffective upon
the rights of plaintiff and liable to be rectified. That defendants were
asked time and again to rectify date of birth of plaintiff but in vain
hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter and written statement was filed.

Plaintiff has placed reliance on Detailed Marks Certificate (matric) and Matric Certificate. Per DMC and Matric Certificate date of birth of plaintiff is recorded as 01.01.1991. Representative of defendants stated that date of birth of plaintiff may be modified as per DMC and Matric Certificate per NADRA SOPs. Copy of DMC & Matric Certificate of plaintiff is placed on file. Copy of DMC & Matric Certificate verified from Controller Examination, Board of Intermediate and Secondary Education, Kohat along with original DMC produced. Original seen and returned. Verified copy placed on file. As date of birth of plaintiff is recorded as 01.01.1991 in DMC (Matric), Matric Certificate and representative of defendants stated at the bar that NADRA will rectify date of birth of plaintiff on the bases of DMC & Matric Certificate, therefore, there is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as **01.01.1991** accordingly. Suit of plaintiff is hereby decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. Defendants may verify Detailed Marks Certificate & Matric Certificate of plaintiff from authorities concerned, if deemed necessary.
