Hence, in absence of proand contra evidence, the stance of defendants is stronger and supported by documentary proof as compared to that of plaintiffs. Thus no prima facie arguable case exist in favor of the plaintiffs at this stage and stance of plaintiffs is subject to proof after recording of pro and contra evidence. In light of what has been discussed above as no prima facie case exist in favor of plaintiffs at this stage, hence, instant application in hand for grant of temporary injunction is hereby dismissed. No order as to costs. Instant r file be consigned to District Record Room, Orakzai after its proper completion and compilation.
