He further stated that succession certificate was issued to petitioners by this court, which is Ex.PW-1/2. Copy of his CNIC is Ex.PW-1/3. Sepcial attorney is Ex.PW-1/4. Copy of petitioner CNIC is Ex.PW-1/5. He lastly requested for issuance of Guardian Certificate in her favour.

Basweer Ali and Fayaza Ali, co-villagers of petitioners appeared and recorded their statement as PW-02 and PW-03 respectively. They stated that husband of petitioner was died on 07.12.2024. They further stated that succession certificate was also issued to petitioners by this court. Photocopies of their CNIC are Ex. PW-2/1 and Ex. PW-3/1 respectively. They supported contents of petition and further requested for grant of Guardianship Certificate in favor of petitioner namely Mst: Gul

Shairan.

Thereafter, ex-parte evidence of petitioner was closed.

Petitioner has proved through their ex-parte evidence to be the natural guardian of minors named above. There is nothing on the case file to suggest that there is conflict of interest between petitioner and minors, hence, the Guardianship Certificate, as prayed for, is granted in favour of petitioner namely Mst: Gul Shairan subject to furnishing

surety bond in the sum of Rs: 100,000/- (One Lac Rupees) with two local and reliable sureties each in the like amount to the satisfaction of this court with a blank stamp paper. The sureties must be men of means.

Notwithstanding, the matter of pension is falling within the ambit of special Law/rules. The department concerned may proceed as per rules accordingly.
