JUDGEMENT 23.04.2025

Orakzai at Hangu

The instant Civil Revision is filed against the impugned judgment order and dated 29.02.2024 of the learned Civil Judge-I, Orakzai vide which the said court has accepted application u/s 12 (2) CPC and after framing of issues direction for recording evidence has been issued.

- According to the petitioners, application u/s 12 (2) CPC of (2).respondents No. 1 to 39 has been accepted and direction for recording evidence has been issued. It is alleged that the impugned order is defective, self-contradictory and the learned trial court has not mentioned any legal reason for the same.
- Arguments of the learned counsel for the parties heard and **(3)**. available record perused. While perusing the impugned order, this court pointed out that in fact there is a typographical mistake in the said order and instead of word "admitted" word "accepted" is written by the learned Judge. The crux of the whole order of the

The instant Civil Revision is disposed of accordingly. Moharrir is directed to make the requisite correction with red ink with reference to this order. No order as to cost.
