


Brief facts in the backdrop are that plaintiff has filed the instant suit for
declaration cum-permanent injunction to the effect that, as per Identity Card
issued by United Arab Emirates his true and correct date of birth is
06.02.1994, however, defendant have incorrectly entered the same as
24.01.1996 which is wrong, illegal and ineffective upon the rights of plaintiff
and liable to be rectified. That defendants were asked time and again to
rectify date of birth of plaintiff but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, he appeared through representative. Authority letter and written statement was filed.

Plaintiff has placed reliance on Identity Card issued by United Arab Emirates. Per Identity Card issued by United Arab Emirates date of birth of plaintiff is recorded as 06.02.1994. Representative of defendants stated that date of birth of plaintiff may be modified as per Identity Card issued by United Arab Emirates per NADRA SOPs. Representative of defendants stated that per NADRA SOPs, second time date of birth would be rectified on the approval of DG Operation before his presence. Copy of Identity Card issued by United Arab Emirates placed on file. As date of birth of plaintiff is recorded as 06.02.1994 in Identity Card issued by United Arab Emirates and representative of defendants stated at the bar that NADRA will rectify date of birth of plaintiff on the bases of Identity Card issued by United Arab Emirates, therefore, there is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as **06.02.1994** accordingly. Suit of plaintiff is hereby decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. Defendants may verify Identity Card issued by United Arab Emirates of plaintiff from authorities concerned, if deemed necessary.
