

Order 13	25.03.2025	<p>Parties through attorneys alongwith counsel present.</p> <p>Vide this order the Court intend to dispose of instant application for contempt of court filed by the petitioners.</p> <p>Arguments heard and record perused.</p> <p>Perusal of the record reveals that petitioners have stated in the instant contempt application that the respondents in violation to the orders previously passed by the court had restrained the petitioners from cultivating the portion of the suit property which was in possession of petitioners. Since the petitioners had been restrained from cultivation by the respondents, thus the respondents have committed the contempt of court orders. Contrary to this the respondents stated that they have not violated any order passed by this court rather petitioners/plaintiffs got no notice from the court of ad-interim injunction.</p> <p>In given circumstances, perusal of previous order sheets would reveal that ad-interim status quo was granted only to the extent of alienation of the suit property, while the contempt of court application is regarding construction over the suit property. After institution of instant contempt of court petition bailiff was directed to submit his inquiry</p>
