stage that whether suit property has been partitioned amongst all the sharers and who is the real owner of suit property. This court also deem it proper to preserve the suit property from further alienation and interference in the possession during pendency of the instant suit, so as to avoid future complications and multiplicity of litigation.

In given circumstances, the application in hand is hereby allowed and temporary injunction for the statutory period of six months or till disposal of instant suit, whichever is earlier, is hereby granted in favour of plaintiffs. All the parties to the suit are restrained from further alienation, cultivation, cutting trees erected over the suit property and any kind of interference in the suit property through any mode of transfer. No order as to costs. File be consigned to District Record Room, Orakzai after its proper completion and compilation.
