DPP for the state present. Accused Abdul Hayaz is absconding. PW/complainant Sarbali Khan present and his statement recorded as PW-8. DPP for the state abandoned PWs Minhaj Uddin and Muhammad Saleem being witnesses of the same fact as deposed by PW-08 and closed evidence on its completion within the meaning of section 512 Cr.PC.

Perusal of record shows that accused Abdul Hayaz S/O Musa Khan R/O Qaum Mishti, Tappa Darway Khel, District Orakzai is charged in the above cited case for the commission of the offence registered at PS Kurez Boya. Accused is absconding and proceedings u/s 512 Cr.PC were carried out.

Prosecution was allowed to produce its evidence within the meaning of Section 512 Cr. PC. Prosecution produced 08 witnesses. PWs Minhaj Uddin and Muhammad Saleem were abandoned by prosecution.

Keeping in view the available record and statements of PWs, this court is satisfied that a prima facie case exists against the absconding accused namely Abdul Hayaz S/O Musa Khan who is intentionally avoiding his lawful arrest, hence, accused is hereby declared as proclaimed offender. His name be entered in register/list of proclaimed offenders. Perpetual warrant of arrest be issued against him.

Police file be returned while file of this court be consigned to record room after necessary completion and compilation. Case property, if any be kept in safe custody till arrest/trial of the accused.
