Resultantly, application in hand is allowed. Accused/petitioners be released on bail on sole ground of compromise subject to furnishing bail bonds in the sum of Rs. 80,000/- with two reliable sureties each in the like amount to the satisfaction of this court. Copy of this order be placed on police as well as judicial record. Record be sent back to the quarter concerned forthwith, while file of this court be consigned to record room after necessary completion and compilation.
