Plaintiffs through counsel present. Defendants have already been placed and proceeded ex-parte. Counsel for plaintiffs requested for summary disposal of the case. Ex-parte arguments also heard and record perused.

Brief facts in the backdrop are that plaintiffs namely Suma

Begum and Alisha Begum have filed the instant suit against the defendants Secretary Village Council Kuriz, and Assistant Director Local Government District Orakzai for declaration and permanent injunction to the effect that as per their school record correct dates of birth of plaintiff No.1 & plaintiff No.2 are 08.06.2010 & 08.06.2014

respectively, while defendants have incorrectly entered dates of birth of plaintiff No.1 & plaintiff No.2 are **08.06.2016** & **08.06.2013** respectively which are wrong, illegal and ineffective upon the right of plaintiffs and liable to be rectified. That defendants were asked time and again to rectify dates of birth of plaintiffs but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned but they are failed to appear before the court despite proper service, therefore, placed and proceeded ex-parte vide order dated:

ID ALAM Claim and contention of plaintiffs are that as per School Record,

their true and correct dates of birth are 08.06.2010 and 08.06.2014 respectively, while defendants have incorrectly entered dates of birth of plaintiffs as **08.06.2016** and **08.06.2013** which are wrong, illegal and ineffective upon the rights of plaintiffs and liable to be rectified.

There is nothing in rebuttal due to ex-parte while plaintiffs produced School Birth Certificates in support of their claim. As per Birth Certificates issued by School concerned, the correct dates of birth of plaintiff No.1 & plaintiff No.2 are 08.06.2010 & 08.06.2014 respectively. Plaintiffs are not seeking any modification in their dates of birth recorded in their Birth Certificates.

As there is nothing in rebuttal due to ex-parte and plaintiffs produced Birth School Certificates, therefore, suit of plaintiffs are hereby ex-parte decreed as prayed for. No order as to cost. This decree
