Representative of defendants stated that there is unnatural age gap between plaintiffs with their son, therefore, he has got no objection on the summary disposal of the case. 
Brief facts in the backdrop are that plaintiffs have filed the instant suit for declaration cum-permanent injunction to the effect that, true and correct date of birth of plaintiff No.1 is **01.01.1965**, similarly correct date of birth of plaintiff No.2 is **1963** however, defendants have incorrectly entered date of birth of plaintiff No.1 **01.01.1980** and plaintiff No.2 is **1975** which is wrong, illegal and ineffective upon the rights of plaintiffs and liable to be rectified. That due to this wrong entry, there is unnatural age of about 08 years between plaintiff No.1 and his son namely Mashrang Khan whose date of birth is 1988 while there is unnatural age of about 13 years between plaintiff No.2 and her

son namely Mashrang Khan whose date of birth is 1988. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

Representative of defendants stated that there shall be at least 16/17 years' age difference between daughter and their parents. Per record, date of birth of plaintiffs are recorded as 01.01.1980 and 1975 resulting into unnatural age gap of about 08 and 13 years. Plaintiffs are not a government servant. The modification sought by plaintiffs will not affect rights of others. Representative of defendants stated that date of birth of plaintiffs may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff No.1 as **01.01.1965** and plaintiff No.2 as **1963**. Suit of plaintiffs are decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any.
