SUMMARY JUDGEMENT

20.05.2025

Plaintiff through counsel present. Representative of defendants present. Written statement along with record submitted. Representative of defendants stated that there is unnatural age gap of 56 and 66 years between plaintiff with her parents namely Azeem Shah and Mst: Zar Jamala, therefore, he has got no objection on the summary disposal of the case. Arguments heard and record gone through.


Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that her true and correct date of birth is **1984**, however, defendants have incorrectly entered the same as **1884** which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That due to this wrong entry, the parents of the plaintiff are younger of about 56 and 66 years from plaintiff, whose date of birth are 01.01.1940 & 01.01.1950 respectively. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

Representative of defendants stated that there shall be at least 16/17 years' age difference between daughter and her mother/father. Per record, date of birth of plaintiff is recorded as 1884. Date of birth of plaintiff's parents namely Azeem Shah and Mst: Zar Jamala are recorded as 01.01.1940 & 01.01.1950, resulting that parents of plaintiff are younger than plaintiff of about 56 and 66 years respectively, how it possible. Plaintiff is not a government servant. The modification sought by plaintiff will not affect rights of others. Representative of defendants stated that date of birth of plaintiff may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as 1984. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
