Plaintiffs through counsel present. Representative of defendants present. Amended written statement submitted. Representative of defendants stated that there is unnatural age gap of 07 years between plaintiff No.1 with her son namely Muhammad Shaheen, therefore, he has got no objection on the summary disposal of the case. Brief facts in the backdrop are that plaintiffs have filed the instant suit for declaration cum-permanent injunction to the effect that, correct date of birth of plaintiff No.1 is 01.07.1989 similarly, correct date of birth of plaintiff No.2 is 01.07.1971, however, defendants have incorrectly entered the same as 01.01.2000 and 26.01.1982 which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That due the said wrong entry, there exist an unnatural age of 07 years between plaintiff No.1 and plaintiff No.2, similarly there is unnatural age of about 07 years between plaintiff No.1 with her son namely Muhammad Shaheen, whose date of birth is 05.04.2007.

That defendants were asked time and again to rectify date of birth of plaintiff

but in vain hence, the present suit.

Representative of defendants stated that there shall be at least 16/17

years' age difference between son/daughter and his mother/father. Per record,

date of birth of plaintiff No.1 is recorded as 01.01.2000 and date of birth of

plaintiff No.2 recorded as 26.01.1982. Date of birth of plaintiff No.1 son

namely Muhammad Shaheen is recorded as 05.04.2007 resulting into age of

about 07 years between plaintiff No.1 and plaintiff No.2, similarly there is

unnatural age of about 07 years between plaintiff No.1 with her son namely

Muhammad Shaheen whose date of birth is 05.04.2007. Plaintiffs are not a

government servant. The modification sought by plaintiff will not affect rights

of others. Representative of defendants stated that date of birth of plaintiffs

may be modified as per NADRA SOPs. There is no need of recording

evidence of the parties. Defendants are directed to rectify date of birth of

plaintiff No.1 as 01.07.1989 and plaintiff No.2 as 01.07.1971. Suit of plaintiffs

is decreed as prayed for. No order as to cost. This decree shall not affect rights

of others interested, if any. This decree shall not affect service record of

plaintiff, if any.
