recovered 1000 grams of opium. Hence, the present FIR.

- 4. After hearing both the parties and perusal of the record, it was found that though the accused/petitioner is directly nominated in the FIR with the allegations of recovery of 1000 grams of opium. However, the report of FSL is not available on file to show that whether the recovered substance was actually opium or otherwise. This fact makes the case one of further inquiry.
- 5. Hence, in view of what is discussed above, the accused/petitioner is admitted to the concession of bail provided he submits a bail bond in sum of Rs. 100,000/- with two sureties each in the like amount to the satisfaction of this Court. The sureties must be local, reliable and men of means.
- 6. Order announced. File of this Court be consigned to record room after its necessary completion and compilation.
- 7. Copy of this Order be placed on police/judicial file.
- 8. This Order is tentative in nature and would have no effect upon the trial of the accused/petitioner.
