




Counsel for the complainant also present.</p> <p>The accused/petitioners seek pre-arrest bail in case FIR No. 34, Dated 19.04.2025, u/s 506/504/436/342/427148/149 PPC of Police Station Kalaya. As per contents of FIR, the local police received information that the elders of caste Utman demolished a room by igniting it and abducted a person. Upon this information, the local police reached the spot of occurrence and found the demolished room. The complainant, Gula Noor s/o Qeemat Khan made a report that he along with people of the locality were present in the room on 18.04.2025 where at about 2230 the present accused/petitioner and co-accused duly armed arrived there, forcefully evict them from the room and demolished the room by setting fire to it. The accused/petitioner have taken one, Deedan Gul and criminally intimidate the complainant party by making aerial firing.
