



<p>Contd. Order 14</p> <p> <b>MUHAMMAD JUNAID ALAM</b> Civil Judge / JM-II Orakzai at Kalaya</p>	<p>26.05.2025</p>	<p>Formal charge was framed. Accused pleaded not guilty and claimed trial. Prosecution was allowed to produce evidence against accused facing trial. Prosecution produced one witness. i.e. <b>PW-01</b> (MHC) in the instant case. He deposed in his cross examination that he has not produced the original register no. 02,19 &amp; 21 before the Court.</p> <p>Perusal of the record would transpire that complainant charged the accused facing trial to criminally intimidate him, however, not a single empty has been recovered from the spot or places of accused. It is also worth mentioning here that the instant case was registered against the accused facing trial on 20.08.2024 and since then, the complainant has not appeared before the court for single date of hearing, which shows their lack of interest in prosecution of the case. Reportedly, complainant has gone abroad for livelihood. There is no criminal history of accused facing trial. Accused facing trial are facing agony of trial since 2024. Even otherwise, there is no probability of conviction of accused on the basis of available record and evidence produced by prosecution so far.</p> <p>In light of above discussion, the instant case is disposed of under Section 249-A Cr.P.C. Accused facing trial namely <b>Mujahid Khan son of Sunab Khan and Wajid Ullah son</b></p>
