

SUMMARY JUDGEMENT

21.05.2025

Plaintiff through counsel present. Representative of defendants present. Authority letter & written statement submitted. Representative of defendants stated that there is unnatural age gap of 11 years between plaintiff and her daughter namely Bibi Israf Jan, therefore, he has got no objection on the summary disposal of the case. Arguments heard and record gone through.

Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, her true and correct date of birth of plaintiff is 01.07.1952, however, defendants have incorrectly entered the same as 01.07.1959 which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That due to this wrong entry, there is unnatural age of about 11 years between plaintiff and her daughter namely Bibi Israf Jan whose date of birth is 1970. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

Representative of defendants stated that there shall be at least 16/17 years' age difference between daughter and her mother. Per record, date of birth of plaintiff is recorded as 01.07.1959. Date of birth of plaintiff's daughter namely Bibi Israaf Jan is recorded as 1970 resulting into unnatural age gap of about 11 years. Plaintiff is not a government servant. The modification sought by plaintiff will not affect rights of others. Representative of defendants stated that date of birth of plaintiff may be modified as per NADRA SOPs. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as **01.07.1952**. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any. This decree shall not affect service record of plaintiff, if any.
