SUMMARY JUDGEMENT 11.06.2025

Plaintiff absent. Representative of defendants present.

Authority letter and written statement filed.

Brief facts in the backdrop are that plaintiff has filed the instant suit for declaration cum-permanent injunction to the effect that, as per Wafaq-ul-Madaris Al-Arabiya Pakistan, Certificate true and correct date of birth of plaintiff is 10.09.2006, however, defendants have incorrectly entered the same as 01.01.2001 which is wrong, illegal and ineffective upon the rights of plaintiff and liable to be rectified. That defendants were asked time and again to rectify date of birth of plaintiff but in vain hence, the present suit.

MUHAMMAD JUNAID ALAM Civil Judge / JM-II Orakzai at Kalaya With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement filed.

Plaintiff has placed reliance on service record. Per Wafaq-ul-Madaris Al-Arabiya Pakistan, Certificate, date of birth of plaintiff is recorded as 10.09.2006. Representative of defendants stated that date of birth of plaintiff may be modified as per Wafaq-ul-Madaris Al-Arabiya Pakistan, Certificate per NADRA SOPs. Wafaq-ul-Madaris Al-Arabiya Pakistan, Certificate of plaintiff is placed on file. Plaintiff shall produce Wafaq-ul-Madaris Al-Arabiya Pakistan, Certificate to the office of defendants for the modification in date of birth as 10.09.2006. There is no need of recording evidence of the parties. Defendants are directed to rectify date of birth of plaintiff as 10.09.2006 accordingly. Suit of plaintiff is decreed as prayed for. No order as to cost. This decree shall not affect rights of others interested, if any.
