



Complainant in person alongwith counsel present.</p> <p>Case was fixed for evidence of prosecution, but counsel for accused in the main case titled as State Vs Jahanzaib etc vide FIR no. 126 dated 31.12.2022 police station Kalaya filed an application under section 249-A Cr. PC, the application was accepted and accused charged in the mentioned case was acquitted from the charges levelled against them.</p> <p>Record of the instant case would reveal that the complainant party in the instant case i.e. Mad no. 10 dated 31.12.2022 under section 324/148/149 Pakistan Panel Code, 1860 were charged as accused, while the accused party registered cross version i.e. Mad no. 09 against the present accused in the instant case. It is also pertinent to mention here that all the accused/person nominated in the mentioned Mad were acquitted in the main case. It is also worth mentioning here that both the counsels of defense in both of the cases stated at the bar that they have no objection if all the accused are acquitted from the charges levelled against them in their respective cases.</p>
