Feroz Khel, Mawali Khel was present. The injured/complainant purchased groceries and given Rs.5000 cash note to the accused and asked for the remaining amount. During that, altercation took place and the accused took out his pistol out from his "Badda Shilwar" and started firing at him, resultantly, he got hit and sustained injury on his leg. Motive for the occurrence is altercation between the parties. His report is verified by Page 1 of 3

FIR NO: 118, DATED: 11.12.2024, U/S 324 PPC, POLICE STATION: KALAYA one Naseeb Gul, who thumb impressed the same. His report was reduced into writing in shape of Murasila and after reading over to the injured/complainant, he thumb impressed the same. Injury sheet of injured/complainant was prepared which was sent to doctor under the escort of constable Muhammad Irshad No. 336, while Murasila was sent to PS for registration of FIR through constable Shabeer Khan No. 1413 and hence, the present FIR.

> After hearing arguments, available record perused.

Counsel for the accused/petitioner at the very (4). outset of his arguments stated that injured/complainant has affected compromise with the accused charged in the FIR. Today, injured/complainant recorded his statement before the court wherein he stated that he has affected compromise with the accused and has pardoned him in the name of Almighty Allah. He has got no objection if the ad-interim bail already granted accused/petitioner is confirmed. He duly impressed his statement. His statement is verified by one Addl: District & Sessions Judge-1 Muhammad Hamza, who also thumb impressed the statement as token of its correctness. Copy of his CNIC is Ex. PA, while compromise deed is Ex. PB.
