**Order 04**

Special attorney for petitioner along with counsel present. Ex-parte arguments heard and record perused.

Petitioner namely Pashmina Bibi widow of Haji Muhammad, R/O Qoum Stori Khel, Tappa Mala Khel, Tarkhu Sam Tehsil Lower, District Orakzai has filed the instant petition for grant of Guardianship Certificate regarding her minor children namely Uzma Bibi, Ameer Hamza and Faiza Bibi. It has been alleged that petitioner is the widow of deceased Haji Muhammad who died on 30.01.2014. It is further alleged that petitioner is the natural guardian of minors named above and the interest of petitioner and minors are common and there is no conflict in their interest, therefore, she may be appointed as guardian of minors named above.

Respondents /public at large were summoned through publication in daily "AWSAF" but no one appeared before the court to contest the instant application, hence, they were placed and proceeded ex-parte.

Thereafter, petitioner produced three witnesses.

Special attorney for petitioner appeared and deposed as PW-01. He stated that husband of petitioner died on 30.01.2014. Death certificate Ex.PW-1/1. Petitioner have three minors namely Uzma Bibi, Ameer Hamza and Faiza Bibi. Copy of his CNIC is Ex.PW-1/2. FRC is Ex.PW-1/3. Attorney for petitioner Ex.PW-1/4 and copy of CNIC of petitioner Ex.PW-1/5. He lastly requested for issuance of guardianship certificate in favour of petitioner.

Relative of petitioner namely Muhammad Anaq appeared and deposed himself as PW-02. He stated that husband of petitioner died on 30.01.2014. Petitioner have three minors. Copy of his CNIC is Ex.PW-2/1. He lastly requested for issuance of guardianship certificate in favour of petitioner.

Relative of petitioner namely Khapir Gul appeared and deposed as PW-03. He stated that husband of petitioner died on 30.01.2014. Petitioner have three minors. Copy of his CNIC is Ex.PW-3/1. He lastly requested for issuance of guardianship certificate in favour of petitioner.

There is nothing on the case file to suggest that there is conflict of interest between petitioner and her minor children, hence, the Guardianship Certificate, as prayed for, is granted in favour of petitioner subject to furnishing surety bond in the sum of Rs: 100,000/- (One Lac Rupees) with two local and reliable sureties each in the like amount to the satisfaction of this court with a blank stamp paper. The sureties must be men of means.
