As per contents of FIR, the local police acting upon information rushed to the emergency room of THQ Hospital Kalaya, where the complainant, Muhammad Ameen soot Iftekhar Ali reported the matter to the police that he along with sherin Hassan were going to Kalaya Bazar for buying the household articles. That, at 1645 hours, the present accused/petitioner and co-accused Imtiaz Ali duly armed and holding sticks were already present there who attacked them and started beating them, where Sherin Hassan got severe injuries on head with the blow of knife by accused Aitezaz Hassan. The accused/petitioner Imtiaz Ali criminally intimidated the complainant party by aiming pistol upon them. Hence, the present FIR.

After hearing both the parties and perusal of the record, it was found that the accused/petitioner is directly nominated in the FIR. Counsel for the accused/petitioner failed to point out any malafidi or ulterior motive on
