






Arguments already heard and record perused.</p> <p>The accused/petitioner seeks confirmation of pre-arrest bail in case FIR No. 43, Dated 24.04.2025, u/s 337-A(ii) PPC of Police Station Kalaya. As per contents of FIR, the local police responding to information regarding the occurrence, reached THQ Hospital and found the injured Ibrar in the emergency room. The complainant reported the matter to the police vide Daily Diary No. 14 of 24.04.2025 at 1710 hours that he was present near the house of Alam Akbar on the eventful day, when the accused/petitioner came there from his back at about 1630</p>

Order No.05		<p>hours and hit him with a stone to kill him; as a result, he (complainant) got hit and sustained injury on his head.</p> <p>After hearing both the parties and perusal of the record, it was found that the accused/petitioner is directly nominated in the FIR for the commission of offence. Medical report supports the prosecution case. Counsel for the accused/petitioner failed to point out any malafidi or ulterior motive on the part of complainant or local police for false implication of the petitioner. The occurrence was taken place on 24.04.2025 whereas the application for pre-arrest bail was submitted on 14.07.2025 after the lapse of more than 15 months. Hence, the accused/petitioner is not entitled to the extra-ordinary concession of pre-arrest bail. Therefore, ad-interim bail earlier granted to the above-named accused/petitioner is hereby recalled and the BBA in hand resultantly stands dismissed.</p> <p>File of this Court be consigned to record room after its necessary completion and compilation.
