

Petitioner alongwith counsel present.</p> <p>Vide this order the court intends to dispose of instant criminal miscellaneous application filed by complainant in connection with case FIR no. 48 dated 05.08.2024 under sections 302/324/34 Pakistan Panel Code, 1860 police station Mishti Mela, Orakzai registered against unknown accused.</p> <p>Argument heard.</p> <p>Brief facts of the FIR are that, on 04.08.2024 at 23:55 hours, the complainant Sadam Hussain son of Taza Khan alongwith Muqadas Khan, Mudassir, Shakir Ullah and Azam Tariq had gone for a wedding ceremony at Badgor. On the way return from wedding ceremony, when the complainant party reached to the place of occurrence, some unknown persons from the near place started firing, due to their firing Fazal Jameel and Hameed Ullah got hit and died on the spot while complainant, Mudassir, Moqadas were sustained injured. One Azam Tariq luckily escaped unhurt. The complainant charged unknown accused for the commission of offence.</p> <p>Perusal of the application would reveal that the petitioner contends that the occurrence took place on 04.08.2024 and since than the local police has not properly investigated the instant case. The petitioner also filed another application for addition of relevant sections of Anti-Terrorism Act to the FIR.</p> <p>Arguments of the same heard at length.</p> <p>Perusal of record and Zamni dated 08.08.2024 would</p>


