
**JUDGEMENT**  
 09.07.2025

This civil revision was preferred by the petitioners against the  
 Order Dated 10.05.2025 passed by the Court of learned Civil  
 Judge-II, Tehsil Kalaya, District Orakzai, whereby application for  
 appointment of local commission, was accepted.

2. The learned trial Court, while accepting the application of the  
 respondents/plaintiffs, appointed local commission for  
 determination of the following points.

- I. *Exact location of the suit property.*
  - II. *Measurement of suit property.*
  - III. *Current possession of the parties.*
  - IV. *Any structure, building or pathway etc. situated in the suit property.*
  - V. *Kind of the suit property i.e., agricultural, commercial and residential etc.*
  - VI. *Digital mapping of the suit property.*
  - VII. *Satellite imaging and topography of the suit property.*
3. During the course of arguments, it transpired that evidence on behalf of both the parties has already been recorded. In such circumstances both the counsels for the parties agreed upon reconsideration of the application for appointment of local commission after hearing arguments on the main case by the trial Court.
4. Resultantly, the petition is accepted. The impugned order is set aside. The application for appointment of local commission shall remain pending before the trial Court which may be re-considered during full arguments on the whole case. Copy of this judgment be sent to the trial Court. File of this Court be consigned to record room after its necessary completion and compilation.


