

Order 08	14.06.2025	<p>Parties present.</p> <p>Vide this order the Court intends to dispose of instant application for contempt of Court filed by the petitioner.</p> <p>Arguments heard and record perused.</p> <p>Perusal of the record reveals that petitioner/plaintiff had stated in the instant contempt of Court application that the respondents/defendants in violation to the orders previously passed by the Court had restrained the respondents/defendants from further alienation and further construction. Since the defendants have been ploughing in the suit property and are raising construction in the shape of a shop in the suit property, thus the respondents/defendants have committed the contempt of court orders. Contrary to this the respondents stated that they have not violated any order passed by the Court.</p> <p>In given circumstances, perusal of previous order sheets would reveal that after institution of instant contempt of court petition bailiff was directed to submit his inquiry report after spot inspection. 

cultivated in some fields and other fields laid barren. He further stated that no trees were cut or erected over the suit property and no construction work over the suit property was done prior to grant of status quo.

It is also worth mentioning here that the bailiff of this court recorded his statement as CW-01. Both the counsels for the parties has cross examined the said CW. During respective cross examinations of the counsel for the parties, he stated in his cross examination that it is correct that the shop was not constructed in the suit fields. Further stated that it is further correct that the shop was constructed in the layer of mountain. It is also correct that the trees erected over the suit property are in the same condition as prior to filing of the suit. Hence, the report of bailiff supports the version of respondents/defendants and furthermore the respondents/defendants stated at the bar before this court that neither they have previously violated orders of this court nor they will violate the same in future.


In light of above discussion, instant contempt of court petition is hereby dismissed being devoid of merits. As no violation of the court orders has been made. However, the respondents/defendants were directed to strictly follow the orders issue by the court and to refrain from any act in violation to court orders. No order as to costs.
