
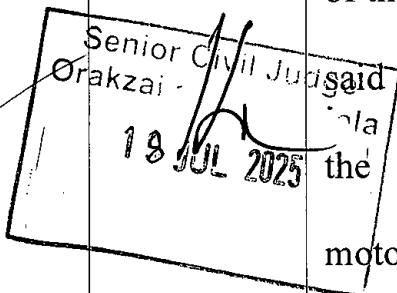

He produced original documents of the motorcycle. The motorcycle is no more required to the prosecution. There is no rival claimant of the motorcycle at present. Moreover, there is strong apprehension of the damage to the motorcycle, if kept in the PS for indefinite period.</p>
