




Order No. 02 continued	31.07.2025	<p>Hearing the arguments of learned counsel and perusing the record it appears that petitioner is the owner of the vehicle. He produced original documents of the said Suzuki. The Suzuki is no more required to the prosecution. There is no rival claimant of the Suzuki at present. Moreover, there is strong apprehension of the damage to the Suzuki if kept in the PS for indefinite period.</p> <p>In view of above, Instant Superdari petition in respect of Suzuki is accepted subject to furnishing surety bond in sum of Rs. 15,00,000/- (fifteen hundred thousand) along with two local reliable and resourceful sureties, each in the like amount to the satisfaction of S.H.O of PS Kurez Boya, L/Orakzai. Petitioner shall be bound to produce it before court of law if required by courts or authorities in respect of the case in hand.</p> <p>Record be returned to quarter concerned.
