

report after spot inspection. He further stated that the stones and woods etc at the suit property are old condition, which shows that they were collected prior to the suit. Hence, the report of bailiff supports the version of respondents and furthermore the respondents stated at the bar before this court that neither they have previously violated orders of this court nor will they violate the same in future.

In light of above discussion, instant contempt of court petition is hereby dismissed being against the facts and devoid of merits. Thus, it is held that no violation of the court orders has been made. However, the respondents/defendants were directed to strictly follow the orders issue by the court and to refrain from any act in violation of the court orders. No order as to costs.
