

PC, however, record shows that the accused/petitioner along with co-accused are nominated in the FIR by the complainant without disclosing any source of information regarding involvement of the accused in the commission of the offence. Accused has not been arrested at the spot. Furthermore, no independent eyewitness of the occurrence. Moreover, complainant charged the present accused/petitioner and co-accused of the instant case for the commission of cross firing upon each other. No</p>
